Ladies and Gentlemen:

Pasadena Area Community College District ("PACCD"), licensee of noncommercial educational radio station KPCC(FM), Pasadena, California, hereby responds to the letter of August 11, 2009 from Mr. Lewis C. Pulley, Assistant Chief, Policy Division, of the Federal Communications Commission.

PACCD employs fewer than five full-time employees who have responsibilities with respect to KPCC. It therefore responds only to Question 3(e) below and provides the following requested information concerning full-time PACCD employees with responsibilities for KPCC:

KPCC is managed by Southern California Public Radio ("SCPR") pursuant to a Public Service Operating Agreement with PACCD. SCPR is the licensee of noncommercial station KPCV, Coachella, California. Because KPCV and KPCC are noncommercial stations, located in different markets, i.e. Los Angeles and Palm Springs, California, respectively, PACCD does not believe that SCPR is a "time broker" as defined by 47 C.F.R. § 3555 Note 2 (j). Although no separate employment data with respect to SCPR is being submitted with this report, that data will be provided upon request.

Question 3(e): Disclose any pending or resolved complaints involving the Station filed during the Station's current license term before any body having competent jurisdiction under federal, state, territorial or local law, alleging unlawful discrimination in the employment practices of the Unit

on the basis of race, color, religion, national origin, or sex. For each such complaint, provide: (1) a brief description of the allegations and issues involved; (2) the complainant and other persons involved; (3) the date of the complaint's filing; (4) the court or agency before which it is pending or was resolved; (5) the file or case number; and (6) the disposition and date thereof or current status.
