Description: RF EXPOSURE

AS DEFINED BY 47 C.F.R. SECTION 1.1307, THE FACILITY IS NOT LOCATED IN ANY AREAS THAT REQUIRE ENVIRONMENTAL ASSESSMENT AND IT WILL NOT HAVE A SIGNIFICANT ENVIRONMENTAL IMPACT. THE REQUESTED OPERATION UNDER STA WOULD BE LOCATED AT THE MAIN TRANSMITTER SITE PREVIOUSLY AUTHORIZED BY THE FCC.

THE EXISTING TRANSMITTER SITE IS SURROUNDED BY SECURITY FENCING AND IS POSTED FOR RF HAZARD. IN ACCORDANCE WITH PART (B) OF THIS SECTION, A STUDY OF RADIOFREQUENCY RADIATION FROM THE PROPOSED OPERATION WAS PERFORMED. THE STUDY FOUND THAT ALL NORMALLY-ACCESSIBLE LOCATIONS COMPLY WITH THE MAXIMUM PERMISSIBLE RADIOFREQUENCY ELECTROMAGNETIC EXPOSURE LIMITS FOR CONTROLLED AND UNCONTROLLED ENVIRONMENTS.

Description: TEMPORARY ANTENNA INSTALL

THIS APPLICATION REQUESTS AN EXTENSION OF THE SPECIAL TEMPORARY AUTHORITY (STA) IN BSTA-20160222ABX, AS EXTENDED BY BESTA-20160809AAW. THE CURRENT AUTHORITY EXPIRES ON FEBRUARY 17, 2017.

DUE TO THE COLLAPSE OF THE STATION'S TOWER ON JANUARY 31, 2016, THE STATION IS OPERATING WITH A TEMPORARY ANTENNA, INSTALLED 9 METERS BELOW THE LICENSED HEIGHT. THE SITE OWNER, CALIFORNIA HIGHWAY PATROL, WAS UNABLE TO ERECT A TEMPORARY TOWER BEFORE THE WINTER WEATHER HIT KELLER PEAK. THE SITE WILL REMAIN INACCESSIBLE UNTIL MID-SPRING.

THEREFORE THE LICENSEE REQUESTS A FURTHER EXTENSION OF THE STA TO OPERATE FROM THE TEMPORARY ANTENNA. GRANT OF THIS REQUEST WILL ALLOW THE STATION TO CONTINUE TO SERVE ITS COMMUNITY.
